6. Motion to approve minutes for July 13, 2020 made by CM Norris, 2<sup>nd</sup> by CM Chunn, passed unanimously.
7. Motion to approve Treasurer Report for July 2020 made by CM Reed, 2<sup>nd</sup> by CM Chunn passed unanimously.
8. Motion to appoint Barbara Norris as mayor pro temp made by CM Reed, 2<sup>nd</sup> by CM Smith, passed unanimously.
9. Motion to procure new engineer to preform traffic study inside city limits approved by CM Reed, 2<sup>nd</sup> by CM Norris, unanimously.
