

**RESOLUTION NO. 0913-2021**

**A RESOLUTION IN SUPPORT OF THE ADOPTION OF PLUM GROVE ROAD INTO THE STATE FARM TO MARKET ROAD MAINTENANCE SYSTEM.**

**WHEREAS**, Plum Grove Road is a city street within the City of Plum Grove maintained by the City of Plum Grove;

**WHEREAS**, Liberty County, through an interlocal agreement with the City of Plum Grove, provides assistance in the maintenance of Plum Grove Road;

**WHEREAS**, Plum Grove Road provides access to many miles of county roads in recently constructed neighborhoods adjoining the City of Plum Grove;

**WHEREAS**, the newly constructed neighborhoods have tens of thousands of residents;

**WHEREAS**, the City of Plum Grove has annual revenues of approximately \$340,000.00 and approximately 700 residents;

**WHEREAS**, the maintenance and expansion of Plum Grove Road necessary to meet the demands of the number of residents is beyond what the City of Plum Grove can afford;

**WHEREAS**, Plum Grove Road connects FM 1010 to the Huffman-Cleveland Road and through the Huffman-Cleveland Road to FM 2100;

**WHEREAS**, the state highways of FM 1010 and FM 2100 provide the sole access to all residents of the City of Plum Grove and surrounding communities;

**WHEREAS**, the growth fueled by the developments adjacent to the City of Plum Grove has made the school district servicing the area, Cleveland Independent School District, the fastest growing school district in the State of Texas;

**WHEREAS**, this growth is expected to continue with many thousands of acres set to be developed; and

**WHEREAS**, this growth is expected to intensify after the construction of SH-99, the Grand Parkway, is completed.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PLUM GROVE, TEXAS:**



**SECTION 3.** This Resolution shall be passed finally on the date of its introduction and shall take effect immediately upon its passage and publication as required by law.


