CM-Chunn made an announcement audience member has 1 chance to speak up to 3 minutes and one time to use the 3 minutes. Do not interrupt the council or others speaking. Otherwise, you will be escorted out of the building and asked to leave the premises. Mary Lou Smith- My point of view on the store. It built up the land so much that it floods the roads and ditches anytime it rains. We flood and the road floods, the pond is useless. The pond is not to the specifications that was originally agreed too. The store owner wants to add more businesses there and should not be allowed to.

Lee Walker- I ran into Ernest Bailes at Ducks Unlimited and is anyone familiar with what is going on with the tower. There is no light on it for airplanes and about a week ago I was home, and a plane was so close to it. He gave Sharron and I an update. We spoke about the tower and the FAA had put a beacon out to all of the pilots to let them know the location or whatever they do to let them know its there. That the new owner of the property said there is an environmental issue with the tower and by March or April they will be taking the

- 9. CM Chunn-City is in communication and discussion with Colony Ridge to come up with a Resolution and a possible path forward so no motion at this time.
- 10. Discussion on Emergency Management Report by James Autrey- Definitely need the high-water signs we are completely out of them. We also need some barricades to temporary block off some roads. They are 106.09 apiece.
- 11. Motion to approve the purchasing of 10 high water signs by CM Lopez, 2nd by CM Chunn, passed unopposed.
- 12. Plum Grove Fire Department Report included.
- 13. Plum Grove Police Department Report included.
- **14.** Motion to Reimburse Plum Grove Fire Department \$1350.00 for bottom 3 panels of garage door due to police car incident made by CM Chunn, 2nd by CM Lopez, passed unopposed.
- 15. Motion to set sick and personal time off for Plum Grove Police Department to 10 days PTO and sick then to add a day for every year of employment after 5 years made by CM Bell, 2nd by CM Lopez, passed unopposed.
- 16. Update council on all Texas Toll Road accounts that previous chief had an account set up for the city that had several vehicles on the account that was not registered to the city. After several phone calls the issues should be resolved.
- 17. Discussion on Plum Grove Court report included.
- **18.** Discussion to pay each attorney Randle Law \$6000.00 and Lloyd Gosselink \$3,500.00.
- 19. Motion to approve Ordinance 0213-2023 regarding the regulation of food establishments including service establishments, retail food stores, temporary food establishments, mobile food units, and roadside food vendors by CM Chunn, 2nd by CM Lopez, passed unopposed.
- **20**. Motion to re-approve an Alcohol and Beverage License for C-Store 7940 Plum Grove Road by Cm Chunn, 2nd by CM Lopez, passed unopposed.
- 21. Motion to deny temporary certificate of occupancy for Pizza Hut located at 7940 Plum Grove Road by CM Chunn, 2nd by CM Lopez, passed unopposed.

Discussion CM Chunn- the only issue I see is the water and gas are not still proper. Secretary Pouncey- I spoke with Dawnel with Bureau Veritas, the gas has not been inspected to the Pizza Hut, but it will pass this time. There is water in the tank and there was an inspection for January 10, 2023, that inspection passed but do you have a current inspection? Mr. Patranella, Pizza Hut owner, explained that the well is going to be drilled when it dries up some and that Mike from C & R Water will provide a report every day to show the water is potable. CM Chunn-The issue is if we issue a temporary CO then the store owner does not follow through with correct protocol then we are right back where we are now. We just need things correct so that when it opens, we know everyone is safe. CM Bell- agreed we would rather be safe than sorry. Patranella- so what you are saying is this is a no until the well is drilled, because we could be looking at 2 months before that happens. CM Chunn- unfortunately we have heard many stories from the store owner. Secretary Pouncey- we could have a special meeting and have a certificate of occupancy granted once everything is correct.

- 22. Motion to approve Silva Can Cad after city attorney approves General Contract to review the retention pond located at 7940 Plum Grove Road made by CM Chunn, 2nd by CM Lopez, passed unopposed. Discussion- It was explained to Mr. Silva that it is believed that the pond at the C-store location is not the correct size and that it is not draining properly. He explained that he had worked with Harris County for many years, and he would be willing to look over the plans and the pond to make sure everything is correct and up to code.
- 23. Motion to Deny an Alcohol Beverage License for taco stand on corner of 1010 and CR 342 due to there are no permits on the stand and it is not up to building code made by CM Chunn, 2nd by CM Bell, passed unopposed.
- 24. Discussion on a community prayer meeting in the parking lot. Permission was granted for the parking lot to be used for a community prayer.
- 25. Discussion on Election Locations Secretary Pouncey explained there is around a \$2,500.00 difference if the election is at city hall for 2 weeks vs only on May 6th election day. That the election will be around \$6,000.00 for having an election, then add around \$2,500.00 to the \$6,000.00 if we have the election at city hall for the 2 weeks and city and court would need to be closed for the 2 weeks of the election.
