<u>Mildred Sowell</u>- Was there an elevation certificate for the city hall. <u>Mayor Arrendell</u>- Yes mam. <u>Mildred</u>- Then why did it flood. <u>Secretary Pouncey</u>- Due to all the development all around us. That is why Fema Flood plain management has been out here. All of the levels and zones are possible going to change again. <u>Mayor Arrendell</u>- Fema said they do not understand how we flooded because of the benchmark. The city hall should not have flooded. <u>Mildred</u>- The housing permits that are being given are going to meet the same criteria that is needed. <u>Mayor Arrendell</u>- New buildings must get the elevation certificate. <u>Secretary Pouncey</u>- If we do not come into compliance or attempt to Fema will remove everyone's flood insurance.

<u>Mark Kelley</u>- My first time attending a meeting. I have decided this is the safest place to be with all the police presence. I have had a few things happen. I started receiving exceptionally large bills in the mail which led to my discovery that my identity had been stolen. I called Liberty County and within 10 minutes Officer Jermey Dodson showed up to

speak with me. I didn't expect it to be that quick. He gathered information, got pictures of the false bills and false charges and within twenty-four hours Dodson had the video and pictures of the guy and within seventy-two hours he had the guy's name. There is now an arrest warrant, and the guy will be charged in Brazoria County. So, I feel like he deserves some recognition for that. He has restored my belief in the Police department.

6. Pinning ceremony for Plum Grove Police Department

Mayor Arrendell- Thank you everyone for attending and watching our city grow. I am now going to hand this over to Ms. Cynthia.

Cynthia Silva- As some of you know I would not be here reporting if it wasn't for Chief Longoria. He called my boss Vanessa Brashier and let her know that I had a huge passion for our communities and that I was ready to take the next steps forward. I have a few things I would like to share with y'all about Chief Longoria and Sergeant Palacios. Tonight, we are honoring the dedication of two of the strongest people that I know. Two people that have helped me become who I am today and two people that have helped make Plum Grove what it is today. Former Chief Brandon Frazier-I was asked to Pin or badge Chief Longoria today. That's a pretty big deal for me, usually you don't turn to someone like me for that. It is with great pride and honor that I stand before you today to takt part in this important ceremony. No action required on Flood Plain management ordinance and compliance for FEMA Council and audience was updated that an Ordinance was passed in 2008 making the city responsible for the flood plain management. Secretary Pouncey explained that she has met several times with FEMA Flood plain management side of things and has been working with FEMA going house to house to determine who had substantial damages. That all flooded houses will need to obtain a permit that will be attached to the property. Depending on the damage will determine the type of permits issued for the house. We just need everyone in the city to be aware that the Ordinance does exist, and it will be available on the website.
