

**ORDINANCE NO. 1209-2024A**

**AN ORDINANCE AMENDING THE CITY OF PLUM GROVE, TEXAS, ORDINANCE NO. 2021 – RULES AND PROCEDURES FOR MEETINGS, SECTION 1 “CITY COUNCIL MEETINGS,” ITEM B “REGULAR MEETINGS” TO CHANGE THE DAY ON WHICH REGULAR CITY COUNCIL MEETINGS ARE HELD; PROVIDING FOR SEVERABILITY; AND PROVIDING OTHER MATTERS RELATED TO THE SUBJECT.**

**WHEREAS**, on April 26, 2016 by Ordinance No. 2021, the City Council of the City of Plum Grove, Texas, adopted certain rules of procedure for the conduct of meetings of the City Council; and

**WHEREAS**, the City Council has determined that changes to Ordinance No. 2021 are necessary; and

**WHEREAS**, the City Council desires to amend Ordinance No. 2021 to change the day on which regular City Council meetings are held; now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PLUM GROVE, STATE OF TEXAS:**

**SECTION 1.0**

Section 1, Item B of Ordinance No. 2021 is hereby repealed and replaced with a new Section 1, Item B as follows:

**B. Regular meetings.**

Regular meetings will be held on the 2<sup>nd</sup> Tuesday night of each month. Except for unusual circumstances these meetings will be at the Council Chambers of City Hall commencing at 7:00 pm. In the event a regular meeting falls on a holiday, during Spring Break, Thanksgiving or Christmas week, the meeting for that day may be rescheduled as determined by Council.


**SECTION 2.0 Severability**

That should any sentence, paragraph, subdivision, clause, phrase, or section of this Ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this Ordinance as a whole, or any part or provision thereof other than the part decided to be invalid, illegal, or unconstitutional; it being the intent of the City Council in adopting this Ordinance that no portion or provisions, or regulations contained herein shall become inoperative or fail by reason of any unconstitutionality of any other portion thereof, and all provisions of this ordinance are severable for that purpose.

**SECTION 3.0 Effective Date**

This ordinance shall take effect immediately from and after its passage as the law in such cases provides.
